### 2. Approval of the Agenda

# 3.1. Minutes of GSA Executive Meetings on February 10th, 2017

### 4. Presentation by SPHSA

SPHSA has two big student-life events, a snowball and Gradball. SPHSA is currently planning Gradball, booked for March 25<sup>th</sup> at Underground to celebrating the graduating cohort. Students are responsible for covering the costs. They are expecting 65 attendees, all graduate students. SPHSA is currently asking for \$500, and will be fundraising to help reach the goal.

Ghaith moved a motion to allocate \$200 to sponsor SPHSA. Seconded by Kiani. 3 in favor. 1 abstained. Sharma will contact them.

### 5. Presentation by BSA

Bangladesh Students' Association (BSA) submitted a proposal for a sponsorship for two events. The first event was the International Language Day that occurred on February 21<sup>st</sup>, and the second event will be a cultural show on April 14<sup>th</sup>. BSA engages in fundraising from the

community, but needs further support from the GSA. Approximately 80% of members are graduate students in BSA.

Ghaith moved a motion to allocate \$150 to sponsor BSA. Seconded by Sharma. All in favor. Ghaith will contact them.

### 6. Presentation by WUSC

WUSC is requesting the GSA to sponsor the Shine a Light Gala, a campaign that provides school supplies to women in refugee camps, and increases the awareness here. All the fundraising proceeds goes to this campaign. WUSC is requesting to purchase a table of 10 seats for the GSA, as well as another table for the performers. It will take place on March 2<sup>nd</sup> at 5:30 in the marquis Hall.

VP Operations & VP Finance donated \$50 each from their discretionary funds to sponsor WUSC

Ghatih moved a motion to allocate \$150 from Student Club budget line to sponsor WUSC. Seconded by Sharma. All in favor. Ghaith will contact them.
