VP Operations and Administration Report - June 3, 2010

Graduate Commons

- Adrienne has been investigating avenues to display student art in the Commons. She has
 been encouraging current MFA students to display their art, however there has been little
 interest. The University's art collection includes works from former BFA and MFA
 students. Costs for displaying pieces from the University collection include an \$80
 consultation fee, \$25 per piece rental fee and any cost associated wit installing the pieces.
 Further opportunities for student art will be pursued. Please contact Adrienne with
 comments and suggestions.
- Katelyn has looked into the possibility of buying linoleum to use as a dance floor instead of renting a dance floor for events. The cost to rent a dance floor is \$15 to \$30 (Dance Saskatchewan) where as the cost to buy linoleum is approximately \$500. Given that we host very few events that require a dance floor it makes sense to continue to rent rather than to buy.
- We are working towards developing a full-time manager position for the Commons. The manager will perform all of the current duties of the office administrator as well as supervise the Commons coordinators and manage the Commons. This new position will reduce the workload of the VP Operations who, in addition to his/her GSA duties is currently responsible for the management of the Commons and its staff. Planning of this position began with the previous Executive and the wage for a full-time employee has been included in this year's staffing budget.
- We will be hosting three BBQs this summer on June 18th, July 15th, and August 19th. All of the proceeds will go towards GSA bursaries. We will also be holding a silent auction for five used computers, with proceeds also going towards bursaries.
- Adrienne and Katelyn are organizing orientation. The Commons will be used as the "home room" for grad students during orientation. We are planning to have a table step up for Live Expo in the Education Gym. The GSA Welcome BBQ will be held on September 23rd

VP Finance Report - June 3, 2010

- 1. The proposed budget for the fiscal year 2010-2011 was not approved in the last AGM meeting due to time. I move a motion to approve it. The things to note on this proposed budget compared to last year's:
 - GSA fees are increased to 118,400. This amount was picked to cover offset all
 the proposed budgeted expenses. The amount is slightly lower than this year's
 actual fees. Each year, the GSA fees has increased, hence the proposed fees is
 realistic based on the trend of last 3 years.
 - The bolded numbers: the Health and Dental fees and CFS fees not to be considered hence won't be discussed (all money received is paid out). The GSA Orientation revenue is the proposed target (based on previous years' trend) for future VP Student Affairs to try and raise from University. The CFS handbook revenue is to be raised by administrator with the help of VP External. The proposed amount is sufficient to cover for next year.
 - CAGS and CFS conferences will be unified into one account know as Conferences. The budget will be same as the combination of the two from previous year i.e. \$5,000.
 - We will be hiring a full time administrator and since Commons is proposed to be open at least up to 6pm from 8:30am part-time admins will be hired to cover for the extra hours. As a result, the GSA administrator budget is proposed to be \$45,000. In order, to stay within the proposed realistic revenue, some changes had to be made. This include the following:
 - O Course council funding budget reduced from \$8,000 to \$5,000. We have never spent more than \$4,500 to date hence the proposed budget is practical. Incase the actual expenditure goes up, excess from previous years will be used to cover for it.
 - o Charitable Donations budget removed completely. There has been no expenditure of this account for the last 3 years. If there is any donation to be made, councilors can approve it from the previous excesses.

- o Bank charges budget reduced from \$500 to \$200. Once again, previous record indicate \$200 is the more than sufficient to cover for it.
- Subscription budget removed completely. This expenditure never exceeds
 \$50 in a whole year hence any expenditure on it will be taken from miscellaneous.
- 2. The donations for the GSA conference (cancelled) will be returned back to the respective department once they notify us. The amount is \$1000 (\$500 from two departments).
- 3. The course council cheques will be circulated during the council meeting on 3rd June 2010. The delay was once again the student list from CGSR.
- 4. The 2009-10 auditing will commence mid June 2010. The accounts will then be filed to Saskatchewan Corporation Board.
- 5. There is a chance the Bursary account will get extra funds from the BBQ events in the summer and computer auctions.

VP Academic's Report - June 3, 2010

- I got in contact with CGSR office to update the information on the website regarding tuition/subsistence for graduates students to reflect what is obtainable in the city. The update is now with programming department to effect the changes.
- At the APC meeting, a report on the introduction of MFA(Masters in Fine Art) in Writing. The need of this course was discussed. It is not meant to be a terminal degree rather transitory. Discussion on restructuring of the Engineering faculty was made, with particular attention on the need for the restructuring and its effects on current and prospective students.
- At Research Scholarly and Artistic Work committee, the position of U of S in research success was discussed based on the national ranking. Nationally, we are trailing behind others, but compared to other western Canadian universities, we are not doing too bad. One of the major indices used is the percentage of CIHR funding.
- During CGSR executive meeting, the effects of the increase in tuition for international students on student hiring were discussed. The dean assured that he will make sure that the money raised from the increament go back into international student scholarship.
