# **Update on Childcare Expansion Project**

On October 17, 2012, the Childcare Expansion Steering Committee forwarded a final draft proposal to the Provost Committee on Integrated Planning (PCIP) for approval before sending it to the Board of Governors for Board I approval at its October meeting. In the draft, approval was recommended for the preliminary project location, program, design, schedule, capital (\$4,800,000) and operating (\$122,500 per year) budgets for the Childcare Expansion Project; and that approval of the preliminary requirements for the Childcare Expansion Project to continue to the next stage of the project development be granted.

The recommendation first went to PCIP, which is responsible for approving which major projects are forwarded to the Board. PCIP considered the project at its meeting in the first week of October. Subsequently, PCIP decided that the project will not proceed to the Board at this time, primarily because it was felt that some additional information related to the project needed to be pulled together before the proposal is forwarded to the Board. In particular, PCIP has requested the following information from the Project Team:

- 1. Information regarding University Advancement's fundraising strategy, initial thoughts on the rollout of the fundraising campaign, and on the likelihood of fundraising that may occur;
- 2. Key dates in the document;
- 3. Information on how the costs of the project compares to other childcare spaces (i.e. are the costs higher or lower, and why?)

In addition, PCIP needs to determine what resources it might have available to provide the University's financial support for this project, considering the University's commitments to other important capital projects.

The implication of this development is that the implementation of the project would delay. With the current underserving childcare spaces on campus, graduate students with demand for childcare spaces on campus might have to remain on the waiting line unless the GSA come up with an alternative plan.

## **UPASS Steering Committee**

The UPASS Steering Committee met sometime this month and identified areas of strengths and weaknesses should the GSA decide to join the scheme. We articulated GSA's position for a deal with Saskatoon Transit. A meeting has been scheduled with representatives of Saskatoon Transit. Many thanks to the Course Councillors that volunteered to be members of this committee.

# **Graduate Retention Program**

We are currently negotiating with the Saskatchewan Governments to include graduates with M.Sc and Ph.D in the provincial Graduate Retention Program. Currently, only graduates from the undergraduate programs are entitled to a \$20,000 tuition rebate. The university management has also promised to talk to the provincial government about it.
