 - Network of practitioners that give students discounted rates ultimately saves the GSA and students money
- Moving forward want to continue building on this relationship and making improvements
- Going forward:
 - Shoppers Drugmart signed on to offer pharmacy network (discounts to students on prescription drugs and certain products) – have been in trial for past year, but are now ready to launch this is Saskatchewan

- Work with University of Saskatchewan to get student e-mail addresses, which the university have thus far been reluctant to release – U. of S. is the only university that doesn't provide this to StudentCare
- GSA Gala and sponsorship contributions want to ensure money is there for student-run and GSA-run events in the future
- We will StudentCare know as soon as possible as to what the decision will be regarding the renewal of the contract
