Additionally, the GSA Sustainability Committee has been meeting regularly and planning the Sustainability Slam & Carbonless Concert for March 29<sup>th</sup> at 6 PM in the Commons. The Office of Sustainability sponsored this event with \$700 and the committee will utilize this fund to purchase prizes, gifts, refreshments and hire musician. Absher has represented graduate students on different committees. She is currently planning the ThinkGrad conference along with VP External and the President, as well as the Gala Coordinator and Naheda Sahtout. The office manager will be receiving her Mental Health First Aid training on March 14 & 15. Absher is also promoting the Graduate Achievement Week and will make a call for volunteers.
