All executives approved all of these actions.

President:

- 1. Requested Executives to send their agenda for PEC meeting along with a list of university officials that executives would want to meet in their tenure of office for update and guidance.
- 2. Update the executive board on the Annual General Meeting of Canadian Federation of Students in Regina.
- 3. Asked the executives to send their content for the GSA newsletter before October 11th.

VP Finance:

- 1. Requested to prepare the agenda package for next regular Council meeting with the following information:
 - a. A list of committees to be ratified and committees which still need academic council representatives.
 - b. Call for representatives on the Students Forum.
- 2. Proposed GSA 2024-2025 Budget was unanimously approved by a quorum of the Budget and Finance Committee. It will be presented to the council at the SGM.

- 3. Requested approval of an audit which was done for the period of May 2022 to April 2023. (Approved by all executives.) Requested office manager update financial statements on the website.

VP Academic:

- 1. Updated the executives board that 12 academic councils have been ratified groups.
