She spoke about the university's third integrated plan and gave an overview of the four cardinal points of the Third Integrated Plan:

Knowledge Creation: Innovation and Impact with a strategy to implement a comprehensive suite of research initiatives at the institutional and college levels. The commitments: Recruit the best faculty; Support faculty and graduate student to succeed; and strengthen strategic focus.

Aboriginal Engagement: Relationships, Scholarships, Programs with strategy to encourage the creation of diversified approaches and flourishing initiatives in every college and unit with appropriate coordination. She further explained that this strategy will be followed with commitments to co-ordinate university-community

relationships; increase visibility of Aboriginal culture and symbols on campus; and showcase success and leverage expertise.

Culture and Community: Our Global Sense of Place with strategy to build on the successes of the Second Integrated Plan and continue to work together collaboratively across boundaries to support our community to be greater than the sum of its parts. Commitments: Celebrate and promote diversity; Model sustainability and stewardship; Foster student creativity and innovation.

Innovation in Academic Programs and Services with strategy to create flexibility and simplicity within programs and services; increase multidisciplinary and provide more experiential learning opportunities. Improve decision-making at the unit level. The commitments are: Focus on leaner-centered programming and curricular innovation; support student success; actively shape student body; and demonstrate effectiveness.

The GSA is working on the survey for all graduate students which is a great opportunity for students to speak up their concerns and thought.

Open House Event for graduate students input of Third Integrated Plan

The GSA is collaborating with Institutional Planning and Assessment Division to organize an open house event where all students can come and learn about the Third Integrated Plan, ask questions and comment upon the Plan.

Issues

Rent of the Residence

- I discussed the issue of residence fee increasing with one manager of the residence office. The clarification is that the GSA executives do not have the authority to approve the mission about the residence fee increasing. The only opportunity that I gave the input about this mission is the meeting held in December and I brought the issue that the graduate students are facing with financial problems. Students complain that the stipend has not been raised but the tuition fee and other expense have increased. However, the Board of Governor had approved the rate of increase. The manager will meet students who sent email to the residence office and then evaluate all the concerns. After the evaluation, GSA will collaborate with the residence office to hold an open discussion about this issue if it is needed.

Childcare Space

- The Student & Enrolment Services Division presented the progress about Childcare Space in January's Course Council Meeting. The GSA executives inquired into the possible spaces for graduate students and relative issues of finance. It was indicated that the more investment the GSA put into the childcare program the easier access graduate students can get As for the potential investment the GSA can provide for childcare program, the executives will discuss and find an appropriate way based on the current budget and next years GSA fee.

7.0 VP Operations and Administrations Report

U-PASS:

WHEREAS the 2012 Graduate Students' Interdisciplinary conference is expected to cost \$4000, with all meal costs expected to exceed \$500.00;

WHEREAS to date, at least \$1300 has been donated/sponsored by various campus departments and community organizations towards the cost of the conference;

WHEREAS sponsorships and donations to the conference are made via written cheque to be deposited directly into the GSA bank account;

BE IT RESOLVED THAT \$4000 be allotted towards funding the 2012 Graduate Student's Interdisciplinary conference titled: Interdisciplinary Knowledge Innovation – "Speak Up for Change" to be held on March 7, 2012.

12.2 Motion sponsored by Gareth Perry the initial motion read:

WHEREAS there is a clear need for additional daycare space at the University of Saskatchewan (U of S), for graduate students; and

WHEREAS a motion to increase the Graduate Student Association (GSA) membership fee, a portion of which was designated as an initiative to directly fund the future construction additional childcare space at the U of S, was defeated at a GSA General Meeting in the spring of 2011; and

WHEREAS the GSA Course Council has not formally been approached by the U of S with sufficient detail regarding funding, partnership or participation in the creation additional daycare space at the U of S; and

WHEREAS the GSA has not been formally consulted by the U of S regarding the creation of a student fee imposed by the U of S on the members of the GSA to fund the creation of additional daycare space at the U of S; and

WHEREAS the monetary burden of funding the creation additional daycare space at the U of S would be placed directly on the members of the GSA; and

WHEREAS the U of S administration has publicly stated that current plan to renovate existing infrastructure to add daycare space on campus at the U of S requires more funding than alternative plans which would create new infrastructure for additional daycare space at the U of S, placing an additional monetary burden on the members of the GSA; and

WHEREAS the GSA is the sole representative of the U of S graduate student body to the administration of the U of S;

BE IT RESOLVED that the GSA request that the U of S, GSA and USSU, along with any other interested party at the U of S, begin formal discussions concerning the addition of daycare space at the U of S; and

BE IT FURTHER RESOLVED that any additional fee imposed on the members of the GSA, by the U of S or GSA, intended to directly fund the creation of additional daycare space at the U of S, or any space of similar purpose, be approved by the members of the GSA in a referendum pursuant to Section 13 of the GSA constitution; and

BE IT FURTHER RESOLVED that the GSA request that the U of S respect the results of any referendum on a daycare fee, held by the the GSA; and

BE IT FURTHER RESOLVED that it is the opinion of the GSA that any daycare space funded by the GSA or any fee imposed on the members of the GSA, must be allocated amongst the funding parties of said daycare space, on the basis of need.

However, Sarah and John moved to add new resolution to the motion. Motion carries with the following resolution:

BE IT FURTHER RESOLVED the GSA fully supports a monetary contribution to expand childcare on campus.

Ehimai and John later moved that the two resolution:

"BE IT FURTHER RESOLVED that any additional fee imposed on the members of the GSA, by the U of S or GSA, intended to directly fund the creation of additional daycare space at the U of S, or any space of similar purpose, be approved by the members of the GSA in a referendum pursuant to Section 13 of the GSA constitution; and

BE IT FURTHER RESOLVED that the GSA request that the U of S respect the results of any referendum on a daycare fee, held by the the GSA"

Be expunged from the original motion. All but one agreed to this and the motion carries. The new motion now reads:

2012/2013 Health and Dental Fee: I have been in discussion with Amanda Smytanuik about the process of reforming the Health and Dental Plans. We are looking at changing the present policy on prescription drugs claims.

3.0 VP Academics

Developing Your Career Potential for Graduate Students Session on Feb 17, 2012 We had successful workshop event. More than 100 graduate students had registered for this workshop. We had to close registration for the GSA common space limitation. We provided light breakfast and tea/coffee for all.

GSA 2012 Conference 7th March, 2012 Update (From Conference Coordinator)

The deadline for abstracts and registration has closed and there were a total of 26 oral abstracts submitted as well as 5 poster abstracts. All poster abstracts were accepted but there were only 21 slots for oral presenters. A call was made out to all GSA executives to see if anyone had time to participate as an abstract reviewer. The final abstract selection committee was Ranjan and I. We used a blinded selection process with an evaluation form to select the abstracts. Once the 21 abstracts were selected, authors were sent an email informing them of the selection and were asked to confirm their attendance. A schedule for the day's event was then created and the abstracts were grouped into 7 sections, with 3 presentations for each section. The presentation will be judged against the others

within their section and total of 7 prizes valued at \$25 will be provided to the top presenters after the event. For the conference logistics, breakfast and lunch will be ordered from a catering company as that ended up being less expensive and would require less preparation than purchasing everything separately and setting it up ourselves. Donuts, muffins and fruit trays will be ordered for the refreshment breaks throughout the day. Coffee will not be purchased but will be made throughout the day. There are currently 45 people registered to attend the full day event, not including GSA executives, volunteers and guests of the presenters. Other activities:

5.0 VP Finance

- 1) We are yet to hear from CGSR despite sending two reminders inquiring on the student list they were to send in order to issue the course council funds for Fall 2011. I urge the CC to put a motion forward to use the student numbers from winter term of 2011 and have the cheques issued effective immediately.
- 2) All the bursary funds have been used for this fiscal year. Like in Fall 2011, the awards were awarded to six successful applicants each getting \$1,000.
- 3) Although the current excess is \$397,387.90, big payments for health and dental premiums (\$274,736,76) along with CFS fees (\$14,525.22) are yet to be made. Payments will be issued this coming week.
- 4) I have attached financial summary (page 3 of this report) for the past four years in order to give CC a clearer picture on our history of financial operations. Commons was in full operation in 2010-11 fiscal year and operated from Jan-April in 2009-10.
