#### **16.0 Motions:**

WHEREAS the GSA is not planning on hosting a GSA Conference this year, and WHEREAS the original budget for the GSA Conference was \$2500.00, which would otherwise be unspent,

WHEREAS the GSA is planning on hosting the first annual Graduate Awards Gala in March of this year,

BE IT RESOLVED that Course Council authorize the GSA Executive to spend \$2500.00 towards unexpected expenses for the Graduate Awards Gala.

#### Moved by John, seconded by Liz

- Normally this fund is used for the conference but over the last few years, the prestige and size of the conference has decreased and for this year we will use this year to restructure it for next year
- Gala has 450 spaces and tickets are being sold for \$25. Since this is not in the budget, we need course council to approve this need to sell 400 tickets to break even
- Hoping this will be budget neutral
- Comment: may be a good idea to do a biannual event (1 year conference, 1 year gala)
- Question: who is the gala open to? Grad students only, or others (spouses, etc) allowed? grad students, alumni and guests.
- How many people have benefitted with the gala and awards and what is the problem with the conference?
- In the past, the conference was opened nationally, so it would be ideal for us to go back to that stage Idea is to create a procedure for the conference so that in the future, it can be planned much earlier and be a larger event
- CGSR has slowly lost interest in the diminishing level of the conference
- When did this decline for the conference begin? In the past it was tried to advertise nationally, there was very minimal bite from other locations
- Use this money towards the planning of the next conference?
  - o Moved by sarah purdy to table the motion, seconded by Rob Perry
- John: urge council to vote yes or no, no point in delaying it
- Discussion about whether gala is needed or not
  - o Nomination for awards shows more prestige than a conference presentation
  - o In the future, this discussion should occur before the decisions are made
  - o Conference used for networking, a gala can be used for the same purpose
  - Can we borrow this money from the overflow instead of using it from the conference fund? same pool

# 16.1 BE IT RESOLVED THAT the wording of the U-PASS referendum question is acceptable to Course Council.

#### **Background**

At the beginning of Term 1, graduate students started expressing their concerns why they had to pay minimum of \$242 per term for bus services. They wanted a reduced rate. The GSA advised that in line with the GSA policies (Policy 2, Elections and Referenda), at least 50 signatories of graduate students would be required to call for a referendum. On September 28, 2012, some graduate students came to the Course Council meeting with a written petition demanding a referendum. The written petition was signed by over 100 graduate students. They also submitted the names of over 200 graduate students who signed online petition demanding a referendum.

During the meeting, the President promised to lead a committee that would negotiate with Saskatoon Transit and come up with "the question" that would go through a referendum. An eight person committee was formed that negotiated with Saskatoon Transit. The process of the negotiation lead to a survey in November, 2012 and culminated in getting a quote from Saskatoon Transit.

#### **The Referendum Question**

Graduate Students' Association (GSA) entered negotiation with Saskatoon Transit to negotiate a U-PASS deal for graduate students. In order to determine if the U-PASS is desirable to graduate students and if the GSA should sign an agreement with the City of Saskatoon, the GSA will be holding a referendum on this issue on Wednesday, February 27, 2013. If the referendum passes, the GSA will enter an agreement with the City of Saskatoon subject to City Council approval. If the referendum fails, then the UPASS issue may not be visited again until there is popular student demand in the future.

Only students registered in the College of Graduate Studies will be eligible for this UPASS. The referendum question is: Do you support the implementation of U-PASS (universal bus pass which would be for terms September-December + January-April + May-August subject to City of Saskatoon Council approval) for graduate students enrolled in the College of Graduate Studies and Research for \$110.85 per term. With a yearly consumer price index adjustment.

Students in one or more of the following categories will be eligible for exemption. Those:

- (1) Living outside the city limits;
- (2) Living in on-campus housing (Ogle Hall, Voyageur Place Residence, Lutheran Theological Seminary and St. Andrew's);
- (3) Enrolled exclusively in distance education courses; and
- (4) Unable to ride bus due to a disability

#### **Motions to Course Council**

- (1) In line with GSA Policies (Policy 2, Elections and Referendum) and Constitution, Section 13.1.7 to 13.1.8: "13.1.7 The placement of all questions in the referendum shall be subject to Course Council approval. Normally Course Council shall approve any question that has garnered sufficient signatures in support; however, Course Council shall retain the authority to reject any question where it finds compelling reason to believe that the passage of the question would constitute a violation of the mission or operating statement of the GSA; a violation of law; a contravention of University policy; a violation of contractual, financial or other obligations undertaken by the GSA; or would otherwise pose a significant threat to the best interests of the GSA or be injurious to the welfare of the graduate students at the University of Saskatchewan. Any such rejection shall require a two-thirds (2/3) vote in support from all voting members of Course Council.
- 13.1.8 The wording of all questions to be placed on any GSA referendum shall be subject to the approval of the Course Council. Course Council shall have the authority to remove or amend misleading statements or extraneous promotional content; correct errors of fact; and edit technical errors of spelling and grammar. Course Council shall not have the authority to fundamentally change the substance of a question"

BE IT RESOLVED THAT the wording of the U-PASS referendum question is acceptable to Course Council.

Motion: David, seconded Dylan

- Many students had asked for a upass referendum, a committee was established to meet and negotiate with the city for the best price
- Josie speaking against due to numbers (differential between undergrads and grad students), there can be lobbying efforts, City councillors may be willing to talk lobby for a equal price, VP external should be on board for lobbying more; Should push back, would mean that couldn't be implemented for September but maybe at a later date
- Worried about the consumer price index adjustment rate done by stats Canada, the choice of which one is use can vary the price
- The contract for this is the same as USSU
- Students should have right to make the decision with what is presented
- Does this included research hour for exemptions: if not doing research on campus, then they will be exempt, we will need to clarify the living in Saskatoon, not on campus but registered as a grad student
- Are there attempts to negotiate a different rate for students using this for other transit times (not peak)
- Exemptions spelt wrong, if we don't take this now, we can renegotiate in 1 year
- After the trial, we can lower the price
- **Point of order:** 1 year condition is not in the wording

Friendly motion by Josie, seconded by Dylan to add: the 1 year trial period commencing in September 2013

- Concerns about other students in residence and the summer term
- Reminder that we are not voting on having the UPASS and voting on the wording of this question
- Course council may have the power to limit it to just 2 instead of 3 terms
- This price is the same as other institutions have in the city (ie: the Siast)
- Transit is committed to running this at a revenue neutral method
- Committee contends the comment that not enough work was putting this into this
- Use of this would increase ridership for the city, will improvement be made by transit?
- More routes will be added, and busses purchased, improvements are being made by the transit system
- Numbers of grad students use bus passes an overwhelming number of students answered the bus pass survey (over 1500) stated they already buy the \$243 bus pass
- This may discriminate against other modes of transport such as biking or walking
- Appeal by a bus pass user to let the students decide
- Has work gone into if there is a procedural contractual loophole that grad students can benefit from the USSU contract?
- The survey wasn't a random sample, a voluntary sample
- Comparing to the  $USSU = 50\ 000\ vs.\ 3000\ GSA$
- Motion to call question: Sarah, seconded by Rob passed
