- GSA Congress is going to be the major event that will accommodate all our needs (social, academic, etc.)
- University is looking for members for Sustainability Committee requires member of GSA

## 8.8 Questions regarding Executive Reports

- Questions: when you go to the CFS what kinds of thing you are lobbying members of parliament for? What CFS is looking for in terms of motions? Have you heard anything about a letter from CFS members looking to defederate from CFS?
  - Each year at CFS meetings they have about 10 issues that need to be discussed and VP External chooses issues that are affecting issues in Saskatchewan
  - This year will mostly will be talking about access to education, funding for education, student debt, money for research education, international student issues
  - We've not written letters to CFS to defederate think we should try to see how we can benefit from CFS
- Question: budget for travel bursaries has been exhausted where will the money come from and will it be presented to council?
  - There are a number of students that haven't picked up travel grants that have a two week window to provide evidence of attendance

- Some students haven't attended conference yet so they will have time to pick up grant, but need to figure out what to do with the money that hasn't been claimed
- Question: There needs to be an announcement for graduate student collaboration, in particular for positions on committee, etc. At the last meeting there was a comment about why the UPASS position wasn't announced that referenced a policy. I couldn't find a policy about why the position wasn't announced. However according to Policy 7.2.1.1: All positions under the GSA will be widely advertised. Postings will be distributed through email, the Student Employment and Career Center Job Posting website and on the GSA website in accordance with Policy 3. Communications. I want to make sure Executives will do this in the future.
  - Didn't say there was a policy for right to first refusal
  - The VP Operations and Communications is responsible for hiring, it is possible she gave right of first refusal. VP Operations will ensure all policies are followed in future in terms of hiring
  - The two positions that the VP Student Affairs just spoke about are unpaid and they are mentioned in the UPASS report. They were also announced at the last council meeting. Council members have first say, but then it will go outside.
- Thanks to Executives for putting minutes and agenda online and having it sent out. If there are ways it could be improved please tell us
- Question: when should we expect an answer from Saskatoon Transit on the bus ridership survey?
  - City takes time to respond and we have asked them several times, so we can't be sure
- Question: Was informed by Saskatoon Transit that survey results should go to UPASS Negotiation committee
  - Yes, the committee was reassured they would get results, and have requested them repeatedly, but still have not
- Question: Where is the process for the audit?
  - Talked to person from CA who tried to accept our offer, as well as several different people who do auditing and they said they are busy

- Recently gave documents to CA will have more information next week
- There was an incident where professor expressed racism in an On Campus news article. Other student councils on campus would like to address institutional racism and this will take all of our efforts. In the mean time we have a couple of option for the people here today if you would like to learn more about Aboriginal People. The Indigenous Voices program is open to graduate students. Also on Oct. 16<sup>th</sup> 2-3:30 at the GSA Commons there is an event called Honouring Aboriginal Women, which is a direct response to the comments this professor made in order to allow Aboriginal women to have their voices heard.

- Question: The amounts for scholarships for Masters and PhD students are just recommendations. Is it the decision of department head to increase scholarships or not?
  - We have confirmation from committee on integrative planning that they will increase funding this will happen next year
  - One member contacted head of their department and like other course councilors communicated for a few months, and the department finally agreed to increase amount. Yes, it is a decision made by the department, not CGSR. It is a movement that should be made by course councilors. Recently CGSR has increased funding to departments, so it is suggested that you continue meeting with them.
  - At previous council meeting it was mentioned that VP Academics will start an academic committee – have advised students who have these issues to bring them and participate on this committee and then they could assist departments and councilors

  - o AGM minutes are approved at AGMs because it's a different voting body
  - AGM minutes will be presented on website, but not necessarily approved
  - Next course council meeting should include previous AGM minutes, not for approval
- Question: Executive meeting minutes are supposed to be online. The policy should be changed to have time limit.
  - They have been hand written, but as soon as they are made available to VP Operations they will be typed up and posted online.
- Question: Does the VP Operations follow the policy of the University or the GSA? For the next course council meeting could we have motion to change policy to ensure hiring positions are advertised to everyone?
  - This is an issue for policy review committee and should be taken to them
  - The GSA is not a separate body of the university and is bound by all university policies
  - Want to ask VP Operations to follow this policy and be required to advertise positions when hiring.

  - Question: At the last AGM there was a motion to strike a committee to establish feasibility of getting puppies and kittens visiting. What is the progress on this?
    - It is important to have response at the GSA council because it was a motion and we need a report
    - Will now accept volunteers for Puppy Committee
  - Will have travel grant report soon. We had 130 student applicants because the number is so large we would give out whole \$10,000 dollars available. The committee met and decided to award as many students as they could. International travel gets \$350 and domestic travel received \$150 30% of applicants were successful. The committee made adjustments to application process for the next round and will have updates as to whether there will be another round once committee meets and will email students regardless of the outcome
    - Decisions were made on selection policies that were not ratified and the committee did not make decisions based on that policy
    - Moving forward we will have to change this
  - Question: Who is responsible for standing committees?
    - o Each standing committee will have an Executive member affiliated with it
    - Can send e-mail to GSA Executive or Ehimai and it will be forwarded to appropriate VP.
    - VPs can get members two ways: VP Operations will advertise or people can approach VP themselves

#### **10.0 Special Reports**

#### 10.1 U-Pass Report

- Implementation started August 19<sup>th</sup>, ended September 30<sup>th</sup>
- During that time there were 1,879 bus passes picked up -66% of eligible students
- Peak days August 19<sup>th</sup> and Sept.3
- 275 opt-outs processed and distance education students on maternity leave automatically opted out
- Implementation challenges recommendations in report are to address these
  - i.e. number of students want to hand in opt-out electronically, staff on hand to assist
- Recommendations for negotiation committee also

Discussion

- Question: Have an approved implementation budget for the UPASS, but the work that you are doing right now, are you doing it as a volunteer? If it's not volunteer, what's the source of budget?
  - We discovered in the way that the contracts were set out that she did not work all of her hours, and had 5 extra hours per week that they have been using to date
  - Have supplied GSA with instructions on how to deal with any problems that arise in future
  - Budget is exhausted
- Would like to thank UPASS implementation committee. Going forward we will ensure GSA hiring policies are followed for UPASS implementation.
- Question: It's good that things are wrapped up for office to take over, but the VP Student Affairs has limited time. Perhaps something can be added to report that after deadline it doesn't fall to Executives to deal with UPASS issues?
  - Responsibilities ended with contract so she can't do anything now
  - o Doesn't think responsibilities for Executive will be great
  - In automatic reply from UPASS e-mail address, a lot of people's questions will be answered – for sticker issues Commons staff will take care of it
  - Could we put this in for next year though so Executives don't have to put in unpaid hours?

- Isn't necessary because the system has been changed so that the workload for the Executives will be minimal. Will suggest for next time that a report is done so that it doesn't require as much
- Initially projected \$5000 to pay Executives for implementation, but they weren't paid in the end
- Question: What are the costs for future implementation if it is done electronically?
  - The forms will be e-mailed in so people don't have to be paid to stamp, etc.
  - This has been requested from students
- Question: Can we communicate with ICT to make process easier?
  - We did this and they helped with software won't need to do this in the future
- For implementation, it is structural authority, not administration that takes up the budget. Through this report and first term practice, this will reduce our budget in the future.
- Have been liaising with USSU to get help on bettering our project, but in the future we want to talk to other universities on how they deal with their students because some of the issues we face are structural that no one has ever thought to fix

- Will it be better to use total budget for that year?
- Does it include health and dental costs, fees for UPASS, CFS? Some argue that only the FSA fee is the budget of GSA fee, not excluding services
- Total budget refers to budget approved at AGM

- Friendly amendment to include: All discretionary expenditures greater than 10% of the budget item or 1% of the total annual budget approved at AGM, whichever is greater, requires GSA Council approval (simple majority).
- Question: what about emergency measures?

Discussion

• Question: What if executives not available to vote on specific expenses, what they should vote on?

- Executive committee requires simple majority to operate, they require 3 members to show up
- Question: On the new changes, the draft of agenda should be sent five days prior to meeting, and the final agenda three days before. Can councilors send motions in that two day period?
  - Yes they can.
- Question: What is the honorarium for Chief Electoral Officer and Chief Returning hours and how will it be decided how many hours they work?
  - They submit report to VP Operations they are accountable to VP Operations and Executive.
- Questions: If GSA ratified group can use Commons for free, why was I asked for damage deposit?
  - Policy manual defers to Commons booking package damage deposit is included, but you get the money back
- Don't think we should take out position statement. It is only three years old and think it has been helpful in the past
  - Vote to suspend policy statement with hope to write a more recent policy statement that reflects current students
- Friendly Amendment to 5.1.2.5 by Ehimai A draft agenda and call for additional agenda items will be sent to councilors at minimum five days before council meeting
  - Only thing this recommendation says that time that academic council has to response increases
- \*\*Friendly Amendment to 2.2.7.3 Council can recommend quorum not less than 8% and recommended by the Executive, subject to debate
- \*\*Friendly Amendment position statement will not be struck
  - Strongly recommend policy be reviewed issue will be defer to policy committee Motion passes

## **11.2 APPROPRIATE GSA SURPLUS FUNDS (no new information)**

WHEREAS the GSA financial statement is in surplus,

WHEREAS the GSA is currently renting the Commons space for a three year period,

WHEREAS the GSA is a non-profit organization, expected to have zero profit,

WHEREAS one of the missions of the GSA is to ensure its members have access to

quality services that support their academic success, and

WHEREAS most graduate students are entrepreneurial,

(A) BE IT RESOLVED THAT the GSA is to establish a dedicated infrastructure account for the purpose of financing a capital project, and move the sum of \$60,000.00 (sixty thousand dollars) from the surplus fund into this special account, and

BE IT FURTHER RESOLVED THAT the GSA Finance Committee and the GSA Council allocates 10% of its annual budget to this pool until such a time the accrued fund is sufficient for capital investment

(B) Motion to adopt supplementary budget

i) GSA Conference \$15,000

ii) GSA Award Gala \$5,000

iii) Rescue Fund \$5,000

BE IT RESOLVED THAT the supplementary budget be adopted to the GSA 2013/2014 annual budget

#### 12.0 New Business

#### **12.1 MOTION 12 - TO RELEASE COURSE COUNCIL FUNDING**

WHEREAS the GSA provides funding to Course Councils so that they may host events for their individual constituencies, and

WHEREAS the quantity of funding provided is based on both the number of students represented by that Course Council and by the attendance rate of Course Councillors to Course Council meetings, and

WHEREAS this funding is released at the end of the fiscal year, and

WHEREAS the first half of the fall term is the natural time to host events to increase awareness of Course Councils,

BE IT RESOLVED THAT the GSA releases some funding to Course Councils upon request of those Course Councillors during Course Council meetings in the fall term. BE IT FURTHER RESOLVED THAT the total funding released to each Course Council in this manner not exceed one third (1/3) of the amount that Course Council would qualify for had that Course Council attended every Course Council meeting during the previous year. These funds will be deducted from the total Course Council funding released at the end of the year.

Required amendment – wherever it says Course Council, it now says Academic Council

  - Decided to follow last year's policies last year the GSA assumed that representatives would attend all of the meetings and based on that number you would get 1/3 of the funding, and then depending on attendance at the rest of the money at the end of the year

# 12.2 MOTION 13 - TO PROVIDE WORKING FUND FOR GSA EXECUTIVE COMMITTEES

WHEREAS the GSA constitution and policies require the President and Vice Presidents to chair several GSA committees and represent the GSA in several university committees WHEREAS important discussions are usually not documented in these GSA meetings due to lack of funds to pay staff

WHEREAS there is some funds in the GSA surplus account

WHEREAS the GSA is a non-for-profit organization,

BE IT RESOLVED that the GSA Council approve the use of \$2,000 from the GSA surplus account to finance GSA committee meetings from October 2013 to April 2014

BE IT RESOLVED that the office of the President, VP Operations and Communication, VP Academic, and VP Student Affairs be allocated \$500 each from this funds for the purpose of committee meetings

BE IT FURTHER RESOLVED that the fund will only be used for the purpose of staff payment to take meeting minutes and when necessary, the provision of basic refreshment during meetings.

Discussion

- Have constant complaints that committee meetings aren't recorded because they are too understaffed
- If it is approved VP Operations will send out e-mail to students if anyone is interested in minute-taking
- Amendment so that the offices of the President, VP Operations and Communications, VP Academic, VP Student Affairs, VP External and VP Finance will be allocated [\$2,000 divided by 6 each] for the purpose of committee meetings

- Why were these numbers chosen?
- Hours per months for 7 months mainly for minute taking
- Why weren't the other VPs included to begin with?
- Their work with committees is not supposed to be as significant

Amendment fails

 \*\*Friendly Amendment – change to: BE IT RESOLVED that the office of the President, VP Operations and Communication, VP Academic, and VP Student Affairs be allocated up to \$500 each from this funds for the purpose of committee meetings

## 12.3 MOTION 15 - TO PAY UPASS ADMINISTRATION FEE

WHEREAS the university will only remit 99% U-Pass fee to the GSA WHEREAS the GSA will remit 100% U-Pass fee to Saskatoon Transit WHEREAS the GSA estimates to receive U-Pass fees from about 3000 graduate students WHEREAS this estimation is for 3 terms

BE IT RESOLVED the GSA Council authorize the VP Finance to spend up to \$10,000 from the GSA surplus to balance the deficit accrued from the 99% remittance from the university

BE IT FURTHER RESOLVED that the \$10,000 is only for the purpose of paying 100% U-Pass fee to Saskatoon Transit.

  - o Yes
- Why are we required to pay this?
  - Administrative costs
- Are there options to move to another provider so we don't have to pay that money?
  - Not sure who this would be only people who has access to student accounts is University
  - All student fees do this

Motion carries

- Why is this estimation for 3 terms and why not 4?
  - $\circ$  Only three terms no summer term
  - One of recommendations in the UPASS report is that this implementation fee is included in original fee – this should be a one-time thing that should have been dealt with last year
- If money is eventually paid to Saskatoon Transit, can't the fee go directly to them?
  - If you can come back and say they will fund the 1% that's great, but this year we don't have it

- Contract that we have signed now lasts until the end of August so nothing can be changed so any negotiations for winter and summer term wouldn't happen to 2014-2015
- Even if we switched source that is providing administration, it would increase implementation costs
  - In the USSU contract, money is sent to University for opt-out and implementation

- Policy 5 clearly indicates that "An information package containing the agenda, previous meeting minutes, reports from all executive members and pertinent appendices will be available to course council members by email and on the GSA website no later than three days before Course Council Meetings".
- Who is arguing about "that previous AGM minutes can only be approved in the following AGM."? Who are "Others have argued otherwise."?
- Why have these concerns not been delivered to the attention of GSA councils?
