Board of Governors. The GSA President will bring this forward in the meetings with senior leaders

to advocate for a seat of GSA in the Board of Governors. If this is something that is not feasible

soon, the GSA President will ask university senior leaders for possible avenues to deliver messages

of graduate students' needs to the Board of Governors.

**5.2** *Monthly budget update* – VP Finance and Operations shared updated budget and expenditures

on an excel spreadsheet with all Executives.

5.3 Black History Month - Registration is still open for event of Black History Month where

Robyn Maynard will speak Thursday, February 17, starting at 7:00 p.m. She is a well-known

author and book writer.

Uju Asiodu - University Library | University of Saskatchewan (usask.ca) profile added to the

library website. VP External Affairs completed two videos and received two write-ups from

graduate students. The videos were recorded on Friday, February 11, at the GSA Commons.

**5.4 GSA Winter Orientation: Curbside Pickup** – Executives will attend both sessions on February

17<sup>th</sup> (swag bag preparation) and 18<sup>th</sup> (the swag bag distribution). The GSA Executives and

volunteers will meet and pre-fill swag bags to prepare for February 18<sup>th</sup>. The goal is to have 500

bags ready.

5.5 Graduate Student Research Conference – The VP of Finance and Operations discussed the

event and upcoming deadline. VP Moradi also indicated that the poster had been updated for the

February 28th deadline. Applications are slowly coming in. At this time, five participants have

submitted —more information to follow next executive meeting.

**5.6 GSA Winter Bursary** – The VP of Finance and Operations indicated forty-five applications have come in so far, with 11 being approved for the subsequent evaluation. The Bursary Committee will continue to work through the procedures.

5.7 GSA Tax Event – The VP of Finance and Operations indicated that he has communicated with the Canada Revenue Agency (CRA) for possible event to be organized by GSA. Two tax information sessions will be set up for March 1<sup>st</sup> and 14<sup>th</sup> via online Zoom meetings. More details to come along with communication through GSA social media and newsletter.

5.8 GSA Annual Awards Gala – The VP of External Affairs indicated that there had been no applications thus far, only questions about the nomination process, letterhead style, and references. VP Chreneski stated that another advertisement would be going out to all graduate students on Monday, February 14, 2022 (by email). The next Awards Committee meeting is slated for February 18<sup>th</sup>. Committee members received confidentiality agreements and rubric grading templates for review.

5.9 CFS Lobbying week (February 22 to 25<sup>th</sup>) – The VP of External Affairs, in collaboration with President Zahan and Erin Calvary, who is the Public Affairs Officer for the Canadian Federation of Students (CFS), will be setting up a meeting with a Member of Parliament (MP) Corey Tochor from the Conservative Party of Canada (Saskatoon - University riding). President Zahan will also have meetings with MPs from British Columbia, Manitoba, and Ontario with conjunction with Canadian Federation of Students. Plans are in place to discuss improving affordability of education (tuition, cost of living, debt) and eliminate financial barriers, housing accessibility and affordability, increased mental health support, fairness for international graduate students, Indigenous learner's rights to education.

5.10 3MT Thesis Competition – The VP of Academic and Student Affairs indicated that an event is already planned for March 25<sup>th</sup>, 2022, as per the Executive Retreat 2021. VP Kamal also mentioned that GSA is looking at having an in-person event at the GSA commons. President Zahan indicated that this would be a challenge with students not going to school and working remotely throughout Saskatchewan and all around the world. The VP of Academic and Student Affairs said GSA might request students to come to GSA Commons if available and see how many responses

he gets. Based on the responses GSA Executives can decide for the event venue. VP Kamal also

indicated that plans would be in place soon with advertising, including posters that will go out

around February 28th, 2022.

The GSA President also had an opportunity to moderate questions-answers session, and final remarks during a BHM fireside conversation. The topic of discussion was making inclusive excellence actual. The event was with Dr. Airini (Provost and VP Academic), Dr. Patricia McDougall (Deputy Provost) and Dr. Erique Lukong (Professor of Biochemistry). There was an urge from Dr. Lukong during the meeting that university should have department-level data to see the percentage of students with Black origin are studying at the USask. The GSA President promised to bring this up in the President's Executive Committee (PEC) meeting and request university to gather such data. A big thanks was provided to all the volunteers, GSA Executives, and graduate students that committed time and effort for making the series of events successful.

- 5.3 Annual Awards Gala The VP of External Affairs stated 11 nomination packages were received. The GSA Awards Committee has extended the deadline until Saturday, March 19<sup>th</sup>. The executive discussed the possibility of having an in-person event for the winners of the Annual Awards at the GSA Commons, with approximately 40-50 people. The Annual Awards Committee will be meeting on Tuesday, March 8<sup>th</sup>, to discuss plans.
- 5.4 3MT Thesis Competition The VP of Academic and Student Affairs indicated that an event for the 3MT competition is already planned for March 25, 2022, Friday according to the Executive Retreat meeting and registration will go until March 19. VP Kamal also said that plans would be in place soon with advertising, including posters that will go out on March 2. The executives discussed Flyer designs; the VP of Academic and Student Affairs will design a plan, add a logo, and have it ready to go. He will also invite three or more judges with diverse academic portfolios and experience for the 3MT thesis competition. The VP of Academic and Student Affairs and President quoted a couple of names for prospective judges that were noted
- **5.5** Graduate Student Research Conference update The VP of Finance and Operations indicated three submissions for the GSA Graduate Student Research Conference, so far, as the deadline has already passed. The next step is to upload the submission and share them through the GSA website, YouTube channels, and GSA Newsletter.
- 5.6 CFS Lobbying week President Zahan, VP External Affairs, and members for the Canadian Federation of Students (CFS), attended a meeting with Member of Parliament (MP) Corey Tochor and his assistance from the Conservative Party of Canada (Saskatoon constituency). Topics of discussion include education affordability, tuition, cost of living, and mental health service increase. The GSA President requested MP Tochor to forward the students' requests to his standing committees and Government critic roles. Unfortunately, MP Tochor did not make any promise regarding such requests. GSA President Zahan has also had the opportunity to attend other Federal

Constituency ridings, including the NDP party of Canada from British Columbia (MP Lisa Marie Baron) and Manitoba (MP Leah Ghazan). These Member of Parliaments were receptive to the GSA and CFS's policy suggestions and supported free education. The Two MPs also promised to take these requests forward to their standing committees, critic roles, want to strongly advocate for students in their caucuses.

- 5.7 How to use U-File for Graduate Students VP Moradi and VP Kamal are working on arranging events to help graduate students to file their own income taxes. Demonstration on U-File, which is free for all graduate students at USask will be demonstrated.
- 5.8 International Mother Language Day The GSA Executives were invited to attend International Mother Language Day organized by Bangladesh Community Association of Saskatchewan (BCAS). The President gave a five-minutes speech to promote the importance of awareness regarding multilingualism, cultural diversity, and multiculturalism. The President indicated that the event went very well overall.

President's Report – GSA Council Meeting, March 2022

Dear Members of Council,

In this report I will present some initiatives that the Executives have been working on and some updates from the Executive team, which includes:

#### 1. Avenue for Graduate Students to Represent at Board of Governors

The Graduate Students' Association (GSA) has been advocating for a seat in the Board of Governors for many years. The University of Saskatchewan Graduate Students' Association is the only Graduate Students' Association among U15 universities, which does not have a seat in the Board of Governors. Therefore, GSA is looking for avenues from the senior leaders on how the voices of graduate students can be heard at the Board of Governors' meetings.

#### 2. National Lobby Week: Canadian Federation of Students

The GSA was able to attend the National Lobby Week organized by Canadian Federation of Students (CFS) to address students' concerns and requests at the federal level. The GSA representatives met Members of Parliaments (MPs) from Saskatchewan, Manitoba, and British Columbia to speak about affordability of education (tuition, living cost, debts), mental health support, parental benefits, etc. Some MPs promised to look into these matters and present the items to their caucus, parliament, standing committees, and in their many critic roles.

#### 3. Delay in Graduate Studies and Minimum Guaranteed Funding Enhancement

The GSA Executives are working with the College of Graduate and Postdoctoral Studies to inquire into the delay in degree programs. Unlike, many other U15 universities, the graduate students at the University of Saskatchewan takes longer than usual to finish their degrees, which adds financial stress in students' lives, education becomes more expensive, and students are delaying in many important life-decisions, including, but not limited to, joining workforce to contribute to the economy, having children (who are the future of this country), buying houses, etc. Moreover, the minimum guaranteed funding that students receive in this university does not reflect the median time needed to finish their degrees. For example, doctoral students take over seven years to finish a PhD. However, the

minimum guaranteed funding that they receive in their first year is usually around for three years. There is no option for graduate students to study part-time and work full-time to support the skyrocketing education costs. Therefore, GSA is requesting minimum guaranteed funding for PhD students to be at least four years, for thesis-based Masters students to be three years. The GSA is also requesting the University to consider providing parental benefits to graduate students during their parental leave.

#### 4. Changes for Graduate Students Living in University Residence

The GSA Executives have strongly advocated for graduate students living in the university residence, as we were receiving many concerns and complaints from these student group for many years. The GSA Executive had many interactions at different levels of the university leadership team to address such concerns and provided constructive criticism and feedback, so that the services are enhanced at university residence. Following such level of advocacy and discussions, the GSA received some updates from the University Residence Office: removal of early termination fee for graduate students, who finish their degree any time during their contract and the students will have the option to finish their contract by staying in the university residence even if the student was graduated earlier than the contract finish date. To address more inclusiveness, students who become pregnant or have babies will have the option to move to the kids-friendly residence without paying transfer fee and can continue to pay their rent according to the original contract until the end of the contract. After the contract ends, the students may choose to continue staying in the kids-friendly building with a new contract of that particular building, or may choose to move out of the residence. Students will also receive double the amount of Residence Cash Card (RCC) credit they used to receive with the option to rollover of the unused amount until the end of the contract.

## 5. Discussion with Studentcare for Enhancement of the Services of GSA Health and Dental Plan

The studentcare suggested a fee increase in the GSA Health and Dental Plan from the upcoming academic year. The GSA Executives decided not to put extra burden on the graduate students, as they are still recovering from the pandemic effect. Therefore, the GSA Executives have decided to use GSA's own fund to cover this extra cost for the continuation of the service provided by the GSA Health and Dental Plan. The Executives are still having discussions about service enhancement with Studentcare, so that students receive more coverage and better services with extensive members in the network.

#### 6. GSA Winter Orientation: Curbside Pickup of Swag Bags

The GSA was able to distribute about 500 swag bags as part of the Winter Orientation activity. The Executives are grateful to the volunteers for helping GSA organize this event.

#### 7. GSA Need-Based Winter Bursary

The GSA was able to provide winter term need-based bursaries to eligible applicants. The GSA is grateful to the College of Graduate and Postdoctoral Studies for this financial support to our graduate students.

#### 8. GSA Annual Awards

The GSA has been organizing Annual Awards that are intended to celebrate graduate students, as well as honor faculty members that have generously supported graduate students in research, scholarly and artistic pursuits. The GSA Award Committee has extended the deadline to submit nominations for awards.

#### 9. International Mother Language Day

In 1999, the United Nations Educational, Scientific and Cultural Organization (UNESCO) declared February 21 as the International Mother Language Day. This day is observed to protect languages used by people around the world. There are a lot of endangered and extinct languages worldwide, including in Canada. Also, there are fewer Indigenous languages, and some are even at the risk of declining further. This year, GSA released a statement to honour this day and also was invited to give a speech at the event of International Mother Language Day, organized by Bangladeshi Community Association of Saskatchewan. The GSA would like to request university to consider this day to be celebrated from upcoming years for a practice of multilingualism, cultural diversity, and multiculturalism.

#### 10. Celebration of Black History Month

Along with the university, the GSA successfully celebrated the Black History Month by honouring the accomplishments made by the graduate students and faculty members coming from the Black Community. The GSA interviewed outstanding graduate students and published the interviews on the University Library website. The GSA is requesting university to seek department-level percentage of graduate students from Black Community for future improvement in diversity.
