3. Approval of Meeting Minutes

3.1 Approval of the GSA Council Meeting Minutes September 15, 2022

Concern raised by Gannon & Proulx-Cullen, CMGSS

Their council was not ratified at the last meeting, so they only attended as non-voting members. However, some non-voting members were marked absent. Proposed that attendance read 'N/A' instead of 'absent' for non-voting members at the Sept 2022 meeting.

The president requested councils to submit an updated list of executives with the ratification package. A list of past council members will not be acceptable instead. If in case, they elect the

same council as the previous year, this needs to be clarified in the package submitted. Councils are required to complete an election process and provide an updated list that reflects the current council with the ratification package.

Student Question: The time doesn't make sense to ratify in August as new students start in September. The deadlines should then be shifted at least to the end of Sept to allow new students a chance to participate.

Another student echoed this concern saying several students would have not arrived on campus as of August.

The President addressed the concern by saying that the current bylaws do not have this provision but said that there was a need to address this problem and find ways to incorporate new student voices. This would require a change in the bylaws for deadlines to be extended till October or November.

3. Other Business

Challen Gladman, English Course Council advocated on behalf of a hybrid format to attend monthly council meetings. They argued on the basis of Section 3.3 of the GSA policies which state that all meetings should be made considering the needs of people in attendance. They voiced concerns around the constantly evolving nature of the Covid-19 pandemic and the threat to immune-compromised individuals, and also how a hybrid model for the meetings would better accommodate neurodivergent individuals from the student community.

The president responded by acknowledging and sharing the concerns raised. He reassured council members that the GSA is making arrangements to conduct a hybrid council meeting; they have ordered the appropriate equipment needed to do so. He also added that according to university policies, members who attended the meeting online we not given voting rights. However, the policies are evolving, and we hope to be online by December 2022.

The Vice President of Finance & Operations also reminded the council members to offer feedback in a constructive manner. He apologized for last month's meeting getting delayed by twenty minutes and thanked council members for their patience.

The President reminded the council of the need for regular and council members for the Bursary Standing Committee. Applications cannot be reviewed until a standing committee is formed. Expressions of Interest (EOI) may be submitted to the Chair mentioning which committee the member wants to sit on.

1. GSA Executive Committee Meeting: October 09 & 24 and November 02, 2022

2. Meeting with Ted^x organization team of University of Saskatchewan: October 19, 2022

Ted^x organization team of University of Saskatchewan is planning to organize a watching event for Ted^x University of Saskatchewan Women on November 02. GSA President and I met with team, and they are requested to sponsor the event's location. Therefore, we, GSA executives, discussed this matter in the bi-weekly executive meeting and all executives agreed to sponsor this event.

3. Lunch with the Candidates Vice-Provost Students & Learning:

- a. Nancy Turner: October 12, 2022
- b. Jerome Cranston: October 17, 2022

The GSA executives discussed the most important issues of our election platform, e.g., funding amount, maternity leave and equity issues, with both candidates.

4. Meeting with Residence team: October 17, 2022

GSA President and I discussed some issues with residence team of University of Saskatchewan.

- a. Reopening Souris playroom and lounge of other residence buildings for social events.
- b. Request to replace or fix old laundry equipment. Old machines make too much noise, and some parts are broken that are harmful for kids.
- c. Also, we discussed the elevator issues, the residents have been facing this issue for a long time (from Spring 2022)

5. Attended Ted^x University of Saskatchewan Women: November 02, 2022

It was a watching event, there were playing the video of three interviews and then the invited people discussed their opinion after every session.

6. Attended regular meetings of my portfolio:

The GSA executives discussed with the senior leaders of our university to increase the minimum guaranteed funding amount. The minimum funding for grad students is 18,000 CAD and it is not enough. The dean of CGPS informed us that they provided different bursaries and scholarships for grad students. However, we find that grad students who have funding less than 16,000 CAD, only they are eligible to apply. Therefore, the dean of CGPS will work on it.

7. Student advocacy related academic and non-academic issues:

For confidentiality, I could not disclose these situations. I have done four meetings with two grad students in the last month to advocate their academic and non-academic situations. As an experienced member, GSA President helped me a lot with advocacy.
