Executive Elections Nomination Form (2025-2026)

Nomination Instructions

Nominees must include the following in their package. (Incomplete packages will be disqualified):

- A two-page single-sided (maximum) resume/CV [focus on past student-leadership and volunteering activities].
- A 250-word statement to appear with the ballots.
- A copy of the nominee's confirmation of enrolment for Spring and Summer Terms (2025).
- Provide the name and NSID of at least one nominator who is a regular student.

Eligibility:

- Be a regular member of the GSA.
- Be a registered student in the University of Saskatchewan College of Graduate and Post-Doctoral Studies for the academic year 2024/2025.
- Not be an election official.
- Not nominate another person for the same position that they are seeking.
- Additionally, nominees must be: **i)** over the age of 18, **ii)** not have been found to lack capacity by a Court of Law, **iii)** must not have the status of bankruptcy, **iv)** must not to be charged for any misconduct at the University of Saskatchewan.

Important Note:

This form (pages 1, 2 and 3) and the above mentioned documents must be submitted as a single document via email to the **GSA Chair/Chief Electoral Officer** at gsa.chair@usask.ca, no later than **12:00 pm on April 04, 2025**. If the nominee is confirmed as an eligible candidate by the Elections Committee, electronic versions of the candidates' statement will be requested.
